Ministry of Corporate Affairs has recently notified Section 135 and Schedule VII of the Companies Act as well as the provisions of the Companies (Corporate Social Responsibility Policy) Rules, 2014 (CRS Rules) which has come into effect 1 April 2014.

Definition of the term CSR: The term CSR has been defined under the CSR Rules which includes but is not limited to:

- Projects or programs relating to activities specified in the Schedule; or
- Projects or programs relating to activities undertaken by the Board in pursuance of recommendations of the CSR Committee as per the declared CSR policy subject to the condition that such policy covers subjects enumerated in the Schedule.

This definition of CSR assumes significance as it allows companies to engage in projects or programs relating to activities enlisted under the Schedule. Flexibility is also permitted to the companies by allowing them to choose their preferred CSR engagements that are in conformity with the CSR policy.

RCF owns and operates two Chemical and Fertilizer Complexes, one at Trombay, Chembur, Mumbai and the other at Thal near Alibaug in Raigad district, Maharashtra, India, consisting of chemicals and fertilizer plants and required off-site facilities. In our plant operations the energy and nutrient efficiencies have improved substantially over past years which demonstrate our unstinted efforts towards protecting environment by adopting recycle and reuse philosophy. At our both units, we have taken several steps for conserving energy, resources and reducing pollution potential.

RCF has been implementing CSR activities since more than 50 years, much before it became as a mandate by Companies Act 2013. All PSUs came into ambit of CSR guideline by DPE on 2010 onwards. Accordingly RCF had lined up many activities keeping in view of CSR mandate. Many of the activities are of continuous & ongoing in nature & have been formulated keeping in mind the location of plant & requirement of beneficiaries.

RCF CSR POLICY DOCUMENT

1. CSR Philosophy

As a responsible Corporate Citizen, RCF believes that it has responsibility to all stakeholders, including the Society in and around its physical areas of operation. The Company believes that it has to ensure optimal utilization of resources by promoting sustainable and inclusive development to benefit the Society.

The Annual CSR Budget shall be put up to Board for approval in the beginning of a financial year. The Committee shall periodically meet and review the execution of programs/projects. CSR Committee shall be assisted by a below Board level committee of executives representing related functions who would coordinate and carryout the directions of the CSR Committee /Board.

5.0 Approach

RCF by itself or through any registered trust or registered society or a company may undertake the execution of the programs/projects promoted by RCF or otherwise.

Necessary partnerships will be forged with a range of stakeholders at the local, state and national level, including Non-Governmental Organizations (NGOs), technical support organizations, public representatives and opinion makers, other Public Sector Undertakings (PSUs), private sector and concerned government departments. Where needed, the services of individual experts/ consultants will also be solicited. Company will review the Policy from time to time based on changing needs and aspirations of the target beneficiaries and make suitable modifications, as may be necessary.

6.0 Impact assessment, monitoring and evaluation

6.1 RCF may engage any reputed third parties who will, on need basis, provide suitable suggestions to enable effective results based delivery and ensure accountability and transparency of various CSR initiatives of RCF.

6.2 The third party will also create the framework for accountable and participatory monitoring, evaluation and impact assessment by preparing mid-and-annual impact assessment reports.

CHAPTER 2: METHODOLOGY

Research Design

A research design is a plan, structure and strategy of investigation so conceived as to obtain answers to research questions or problems. The plan is the complete scheme or program of the research. It includes an outline of what the investigator will do from writing the hypotheses and their operational implications to the final analysis of data.

Descriptive study designs can help you show whether your program is operating as planned, provide you with feedback about the services you offer, determine whether your program is producing the types of outputs and outcomes you want, and help clarify program processes, goals and objectives. This is an ideal design for an evaluation study where the context is known to the researcher and the research questions need further description to evaluate the program.

Thus, a Descriptive study design was used with Quantitative method to collect information from the beneficiaries and Qualitative method to gain insights in the workings of the implementing partners and RCF officials. The quantitative descriptive design is concerned with describing the characteristics of a particular group, with description of certain facts concerning that group.

Quantitative Method was used as is normally done in a Descriptive study design. This helped best to establish the incidence, extent and magnitude of the program. There was an attempt to seek information about the program to evaluate its planning, implementation and outcomes. There was no attempt to theorize the data to explain the phenomena. Findings are generalized based on the response of the sample.

Research Questions

The questions are a guiding beacon for a research study and the reason to find answers. These questions further help to define the objectives of the study.

- 1. What were the objectives of the program?
- 2. Were the objectives in line with the needs assessed in the baseline survey?
- 3. What were the intended outcomes?
- 4. Have the outcomes been met in the implementation?
- 5. What are the benefits to the target population?
- 6. What is the extent of effectiveness of implementation of the program?
- 7. The possible areas of corrections/ improvement

The analysis and design followed the basic essence of midterm impact assessment on the following aspects

Did the overall goal match needs of the project area? Did the project's baseline data correctly address needs of the area?

What outputs were achieved and whether they were according to the plan? Was the implementation schedule as planned?

Did the outputs help achieve the goal? Did the project have any unique feature? Comparing the inputs to the extent of goals achieved, can project implementation be considered to be effective?

What were the various tangible and intangible? Positive and negative impacts (Socio=economic, Environment, Policy, Technology, Awareness) On different stakeholders of the project?

Sustainability

Would the impacts created by the project sustain? Considering the present course of project, is the project sustainable? If not, what modifications and corrections need to be done with project execution methodology?

Sources of Data

The research team focused and collected only primary data from the field. They had interviews with the beneficiaries and got their views to understand the impact of the program. To get a more holistic view, they interviewed the implementing agencies to understand the implementation, strengths and challenges. Questionnaires consisting of majorly close-ended questions focused on the information and experiences of the beneficiaries of various programs services were prepared respectively. Interview schedule for the officials of implementing agencies was prepared which comprised of open ended questions.

Sampling criteria

Sampling is simply stated as selecting a portion of the population, in the research area, which will be a representation of the whole population. The usual goal in sampling is to produce a representative sample (i.e., a sample that is similar to the population on all characteristics, except that it includes fewer people because it is a sample rather than

the complete population). Simple random sampling was used in order to select the samples. A simple random sample is meant to be an unbiased representation of a group. It is the most basic sampling procedure to draw the sample.

Brief Description:

RCF (Rashtriya Chemicals and Fertilizers Ltd.) procured medical equipment for Pandit Madan Mohan Malviya Shatabdi Hospital in Govandi, Mumbai. The procurement and providing 4 Cautery Machines aims to enhance healthcare services for the local community by providing essential medical tools and infrastructure.

Healthcare remains one of the most critical pillars for the development and well-being of a community, particularly in rural India. Access to quality healthcare is often limited in these areas due to a shortage of medical facilities, equipment, and trained staff. Rural populations face significant health challenges, including a higher burden of communicable diseases, maternal and child health issues, and non-communicable diseases, compounded by a lack of healthcare infrastructure.

By focusing on the promotion of healthcare, projects like this aim to bridge the gap between healthcare needs and available resources. Equipping hospitals with the necessary medical tools is essential for improving the overall health outcomes of rural and underserved populations. This thematic area supports achieving SDG 3 (Good Health and Well-being) by ensuring access to essential healthcare services, promoting universal health coverage, and reducing mortality rates.

Impact Assessment Using the REESI Model

Relevance

The project is highly relevant to the healthcare needs of the local community. Govandi, while part of Mumbai, has pockets with lower access to quality healthcare, similar to rural areas. The equipment provided, Cautery Machine is often used during surgery to remove unwanted of harmful tissue. It can also be used to burn and thus seal blood
vessels. This helps reduce or stop bleeding during surgery or after an injury improves the hospital's ability to serve patients, especially those in urgent need of specialized treatments. The project aligns with SDG 3 (Good Health and Well-being), as it strengthens the health system in a high-demand region.

Efficiency

The procurement process for the medical equipment was completed in a timely and cost-efficient manner and 4 Cautery Machines received and Machines are installed & all 4 are in working condition. The funds were utilized to provide critical medical tools, which are now fully operational. The hospital staff has been trained to use the equipment, ensuring optimal utilization.

Effectiveness

The project has effectively improved the hospital's capacity to provide critical healthcare services. Patients from low-income groups who depend on the public healthcare system are benefiting the most. However, effectiveness could be further enhanced with complementary infrastructure support, such as maintenance facilities for the new equipment.

Sustainability

The project is sustainable in the short to medium term, as the hospital management has integrated the new equipment into their day-to-day operations. However, for long-term sustainability, there needs to be a structured plan for regular servicing and upgrading of the equipment. The project contributes to SDG 9 (Industry, Innovation, and Infrastructure) by improving healthcare infrastructure.

Impact

The immediate impact of the project is the increased ability of the hospital to serve more patients and provide better care. The medical equipment has particularly benefited low-income and vulnerable populations who otherwise might not have access to such facilities. The project has significantly improved health outcomes in the region.

Alignment with SDG Goals

- SDG 3 (Good Health and Well-being):
- The project directly contributes to improving health and well-being by enhancing the hospital's capacity to diagnose and treat patients effectively.
- SDG 9 (Industry, Innovation, and Infrastructure):
- By upgrading the hospital's infrastructure, the project also supports innovation in healthcare and contributes to strengthening the public health system.

Beneficiary Interaction Findings:

Hospital staff and Dr. Jayant Chilkund MBBS, M D, FICOG Senior Medical officer B M C Shatabdi Hospital at Govandi Mumbai expressed that the new equipment has allowed them to handle increased patient loads more efficiently and is contributing to faster treatment and better health outcomes.

All Beneficiaries are nearby Chembur, Mankhurd, Navi Mumbai, Community members reported a noticeable improvement in healthcare services since the installation of the new equipment.

Healthcare providers have highlighted improved accuracy in treatment and patient management capabilities.

Recommendations

- Establish a Maintenance Support Plan: RCFL should collaborate with the hospital to establish a technical support and maintenance plan to ensure the equipment remains functional in the long run.
- Allocate a Budget for Regular Upkeep: Both the hospital and RCFL should consider allocating a dedicated budget for the regular upkeep and eventual upgrading of the medical equipment.

The project demonstrated significant benefits, particularly in improving healthcare outcomes in the Govandi area.

The promotion of healthcare, especially through nutritional interventions, is essential in addressing the widespread issue of malnutrition in rural and underserved urban areas of India. Malnutrition affects cognitive development, educational outcomes, and overall health, especially in children. Mid-Day Meal (MDM) schemes directly address the challenge of malnutrition by providing nutritious meals to schoolchildren, encouraging

regular school attendance, improving concentration in studies, and contributing to better health outcomes.

In rural India, where economic challenges are more acute, mid-day meal programs play a vital role in supplementing children's nutritional needs.

Impact Assessment Using the REESI Model

Relevance

The Mid-Day Meal project addresses a critical need for nutrition among schoolchildren in Mumbai's Trombay area, id-day-Meal to schools Students 1) Jawahar School, Chembur 2) Janta Welfare English School, Chembur& 3) Chembur Welfare School Chembur where many families struggle to provide regular, nutritious meals. By supplying meals to 2,800 students in 29 unaided schools, the project ensures that children from economically weaker sections receive daily sustenance, which is crucial for their health and learning. This initiative is highly relevant, as it aligns with both the Right to Education Act and the National Nutrition Mission.

Efficiency

The project was efficiently rolled out by the Annamrit Foundation with support from RCFL. Meals are prepared and distributed on time, ensuring that students receive fresh, hygienic food daily. However, there were occasional logistical issues, such as delays in food delivery due to traffic or weather conditions, which caused some disruption.

Effectiveness

The Mid-Day Meal program has been effective in achieving its primary goal of improving nutrition among schoolchildren. Teachers have observed better concentration and participation in the classroom, which can be attributed to regular meal intake. This has indirectly led to better academic performance.

Sustainability

The project is sustainable in the short term, as funding has been secured for the initial phase, and operational structures are in place. However, long-term sustainability may require continued financial support and collaboration between RCFL and local governments to ensure uninterrupted service.

Impact

The impact of the Mid-Day Meal project is substantial, both in terms of improving children's health and supporting their educational growth. Children are now more

regular in their school attendance, and their overall health and academic performance have improved due to regular nutritional intake.

Alignment with SDG Goals

This aligns with Sustainable Development Goals (SDG) 2: Zero Hunger, SDG 3: Good Health and Well-being, and SDG 4: Quality Education.

Beneficiary Interaction Findings

Students: Sunil student of class IV, and many students expressed that the mid-day meal is often their most substantial meal of the day. They reported feeling more energetic and focused during school hours.

Parents: Parents were grateful for the project as it eased their financial burden and ensured their children were receiving nutritious meals.

School Authorities: Mr.Goraksh Gambhure, Mrs. Abrira Dasgupta Supervisor and Teachers reported improved student attendance, better classroom behavior, and more attentive learners since the program began.

Teachers: Most teachers reported that meals were delivered on schedule and noted improvements in student performance post-lunch. However, some minor delays were reported, particularly during the rainy season.

Recommendations

• Develop a Contingency Plan for Weather Disruptions: To avoid meal delivery delays during bad weather, RCFL and the Annamrit Foundation should create contingency plans, such as pre-preparing dry meal packs or identifying alternative delivery routes.

• Increase Community Engagement and Awareness: Organize awareness sessions for parents to educate them about the nutritional value of the mid-day meals and the broader benefits of regular attendance in school.

• Implement Nutritional Monitoring: Introduce a nutritional monitoring system to track students' health improvements over time. This could involve regular health checkups to measure height, weight, and overall physical development, which would demonstrate the tangible benefits of the mid-day meals.

The Mid-Day Meal program in Trombay, funded by RCFL, has been instrumental in addressing the nutritional needs of 2,800 students across 29 unaided schools. The program has proven to be relevant, effective, and impactful in promoting better health and improving school attendance.

The project supports the goals of the Swachh Bharat Abhiyan, aiming to reduce open dumping and promote proper waste disposal, which is crucial for improving sanitation and public health in high-density areas.

Efficiency

The project has been efficiently implemented with the distribution of dustbins to the designated areas on schedule. However, some challenges were noted in terms of regular waste collection by local authorities, which reduced the overall effectiveness of the project.

Effectiveness

The project has been effective in promoting cleanliness and improving waste disposal practices in the targeted areas. Residents have become more aware of the importance of proper waste segregation and disposal, and the overall sanitation of the areas has improved.

Impact

The project has had a positive impact on public health and sanitation in the areas where the dustbins were distributed. Cleaner environments have been associated with fewer health complaints, and residents have become more conscious of cleanliness. However, the full impact of the project will depend on ongoing community involvement and waste collection efficiency.

Sustainability

The sustainability of the project depends on the continued maintenance and regular collection of waste. While the provision of dustbins is a positive step, ensuring consistent waste disposal services and raising community awareness on hygiene practices will be crucial for the long-term impact of the project.

Identified Gaps

• Inconsistent Waste Collection: While dustbins were provided, there were instances of irregular waste collection, leading to overflowing bins in some areas.

Alignment with SDG Goals

By providing dustbins, the project has encouraged better waste disposal practices and cleaner surroundings, contributing to SDG 3: Good Health and Well-being and SDG 6: Clean Water and Sanitation

Beneficiary Interaction Findings:

Residents of Slum Areas: Residents welcomed the initiative, stating that having designated dustbins has reduced the amount of waste scattered around, resulting in cleaner surroundings and fewer incidences of foul odors and pests and the local Community Leaders mentioned that the project has led to more organized waste collection and helped in raising awareness about cleanliness in the community.

Residents of Residential Societies: They noted a visible reduction in littering in their neighborhoods. Some also mentioned that the availability of dustbins made it easier to dispose of household waste, improving their living environment.

Recommendations

- Coordinate Regular Waste Collection: Collaborate with local waste management authorities to ensure timely and consistent waste collection, particularly in high-density areas like slums.
- Introduce Awareness Campaigns on Waste Segregation: Implement educational programs to encourage residents to segregate waste at the source. This could involve training workshops or distributing informational materials on recycling and proper waste management practices.
- Expand the Initiative to Include Recycling Programs: As a follow-up to the dustbin distribution, introduce community-led recycling programs to further reduce waste and promote environmental sustainability.

The dustbin distribution project funded by RCFL under the Swachh Bharat Abhiyan has made significant contributions to improving sanitation and public health in the slums and residential societies of Mumbai. For project's long-term success it is important that all stakeholders address the gaps such as irregular waste collection and the need for greater community awareness. With continued collaboration between RCFL, local authorities, and community members, the project can have a lasting impact on promoting cleaner, healthier living environments.

The theme, "Promotion of Healthcare," covers initiatives aimed at enhancing the health and well-being of communities, with a particular focus on providing fundamental services like clean water, sanitation, and medical facilities. In rural India, access to clean drinking water is crucial for promoting good health, as it helps prevent waterborne diseases, improves overall quality of life, and contributes to economic productivity. Safe drinking water is a foundational aspect of healthcare, especially in under-resourced areas where healthcare infrastructure may be limited.

By supplying clean drinking water to villages in Raigad District, the project directly addresses the health challenges faced by rural populations, providing a sustainable solution to water scarcity and poor water quality, both of which are major public health concerns.

Brief Description:

Healthcare access in rural India remains a significant challenge due to a lack of infrastructure and resources. Under the thematic area of Promotion of Healthcare, this project provides critical medical equipment to sub-centres serving rural populations. Access to medical equipment is vital for primary healthcare centres (PHCs), as they are the first point of contact for medical services in rural areas.

PHCs play a critical role in delivering essential healthcare services to rural communities. Equipped with the necessary medical tools, they are able to diagnose and treat common ailments, monitor maternal and child health, and provide preventive healthcare services. This project supports SDG 3 (Good Health and Well-Being), which aims to ensure healthy lives and promote well-being for all at all ages, by improving healthcare delivery to underserved populations in the Raigad district.

Impact Assessment Using the REESI Model

1. Relevance

This project is highly relevant, as it focuses on improving access to healthcare services for rural populations. Equipping the 9 sub-centers with essential medical tools ensures that they can provide timely and effective medical care to locals. Full funds utilized and provide Medical equipment's', furniture, Beds, Medical equipment's& Medicine kits to doctors which required every day while working in PHC. The project is aligned with India's National Health Mission, which seeks to strengthen healthcare infrastructure in rural areas.

2. Efficiency

The project has been efficiently implemented, with RCF providing the necessary equipment in a timely manner. The medical equipment has been well-integrated into the daily operations of the sub-centres, enhancing their capacity to serve patients. The Promotion of Healthcare in rural and underprivileged urban communities is essential for enhancing public health outcomes, particularly in areas where access to healthcare services is limited. The mobile medical van project addresses critical gaps in healthcare accessibility by delivering essential health services directly to communities. This is aligned with the United Nations' Sustainable Development Goal 3 (SDG 3), which aims to ensure healthy lives and promote well-being for all at all ages.

In rural and semi-urban regions like Raigad and the slums of Trombay, access to healthcare facilities is often limited by distance, poverty, and lack of transportation. Mobile Medical Vans provide an effective solution, bringing healthcare services directly to the population's doorstep. This project is especially impactful in serving marginalized communities that otherwise have limited access to basic healthcare.

Impact Assessment Using the REESI Model

1. Relevance

The Mobile Medical Van project is highly relevant to the healthcare needs of both the Trombay and Thal regions. By targeting slum areas and underserved communities, the initiative addresses a critical gap in primary healthcare services. RCF has partnered with Wockhardt Foundation to provide free primary health care through Mobile Medical Vans in Thal Unit slums, assisting approximately 50,000 patients annually.

2. Efficiency

The partnership between RCF and Wockhardt Foundation has resulted in the efficient deployment of two Mobile Medical Vans, covering a large population in the slums of Trombay and Thal. The vans are equipped with essential diagnostic tools, medicines, and trained healthcare personnel. The operational model allows for quick service delivery, with approximately 250,000 patients receiving primary care annually. However, there is a need for better scheduling and communication with the communities to ensure that patients are aware of the vans' presence.

3. Effectiveness

The project has been highly effective in delivering essential healthcare services to the target population. The vans provide diagnosis, treatment, and follow-up services for common health issues, while also conducting health awareness and preventive care programs. The initiative has helped in reducing the strain on local healthcare centers by

treating manageable cases at the community level. Furthermore, the medical vans have played a significant role in maternal and child health by providing prenatal and postnatal care.

4. Sustainability

Sustainability is a challenge in mobile healthcare services due to the continuous need for funding and resources. While the project is effectively addressing current healthcare needs, its long-term impact depends on continued financial support from RCF and partnerships with local health authorities. Moreover, regular maintenance of the vans and timely replenishment of medical supplies are essential to ensure uninterrupted service. Capacity building of local healthcare workers to eventually take over some services could enhance sustainability.

5. Impact

The impact of the Mobile Medical Van project has been profound. By serving approximately 250,000 patients annually, the vans have contributed to significant health improvements in the target areas. The project has resulted in reduced morbidity rates for common illnesses, better maternal and child health outcomes, and increased awareness of preventive healthcare. Furthermore, the project aligns with SDG 3 by improving healthcare accessibility and contributing to the overall well-being of underserved communities.

Recommendations

- Ensure Regular Maintenance: Implement a strict maintenance schedule for the vans and medical equipment to ensure that they remain operational at all times. Consider having backup vans or alternative service models in case of breakdowns.
- Emphasize Preventive Health Education: The mobile vans should include more robust health education programs, with a focus on preventive care, sanitation, and nutrition, helping reduce the long-term healthcare burden.

The Mobile Medical Van project implemented by RCF in partnership with Wockhardt Foundation has had a significant positive impact on the healthcare outcomes of slum communities in Trombay and Thal. The project has effectively addressed primary healthcare needs for approximately 50,000 patients annually, enhancing access to medical services in underserved areas.

In rural areas such as Jalna, access to proper sanitation facilities remains limited. The construction of toilet blocks in schools not only ensures that students, especially girls, have access to clean and safe sanitation but also fosters a culture of hygiene and cleanliness in the broader community. This project

contributes to improving overall health and promoting dignity, especially for girls and women, who often face barriers in accessing safe sanitation.

Impact Assessment Using the REESI Model

1. Relevance

The construction of toilet blocks is highly relevant to the community's needs, particularly in a school setting where students often lack access to safe and hygienic sanitation. The project aligns with both national sanitation initiatives such as the Swachh Bharat Abhiyan and global objectives like SDG 6, which focuses on improving water and sanitation. The presence of well-maintained toilet facilities also helps promote better health, reduce absenteeism, and create a conducive learning environment.

2. Efficiency

The project was executed efficiently, with the construction of well-designed toilet blocks that cater to the specific needs of students. The toilet blocks are gender-segregated and include provisions for hand washing, which ensures a hygienic environment. However, a need for better waste disposal mechanisms and regular cleaning schedules was noted during beneficiary interactions. The funding provided was appropriately utilized, and the project was completed within the stipulated time frame.

3. Effectiveness

The project has been highly effective in improving sanitation in the school and community. It has led to increased attendance, particularly among female students, who now feel more comfortable attending school regularly. Additionally, the availability of hand washing facilities has improved hygiene practices among students. However, the project's effectiveness could be further enhanced by integrating regular health and sanitation awareness programs in the school curriculum.

4. Sustainability

The sustainability of the project largely depends on the regular maintenance and cleanliness of the toilet blocks. While the construction of the toilet blocks addresses immediate sanitation needs, the long-term sustainability of the project will require a continuous commitment from the school authorities and local government to maintain and clean the facilities. Additionally, promoting hygiene awareness through the school system will ensure that the facilities are used effectively and maintained over time.

5. Impact

The impact of the project on the students and the local community has been significant. The newly constructed toilet blocks have contributed to better health and hygiene, leading to reduced incidences of waterborne diseases and other hygiene-related health issues. The project also supports SDG 6, contributing to the goal of providing access to adequate and equitable sanitation for all. The increased attendance, especially among female students, reflects the project's positive impact on education, health, and overall well-being in the community.

The Financial Assistance for the Construction of Toilet Blocks at the Wellness and Culture Centre in Jalna has made a substantial contribution to improving the sanitation and hygiene standards in the school and community. While the project has been effective in promoting better health and reducing absenteeism, addressing the identified gaps—such as waste disposal, maintenance, and hygiene education—will be crucial for ensuring long-term sustainability. By continuing to support sanitation initiatives like this, RCF can play a pivotal role in improving public health and well-being in rural India.

One student was very happy and said, "I feel less tired now that I can drink cold water during breaks," and "It's nice to have clean water at school. I used to worry about getting sick from the tap water."

Educators reported noticeable improvements in student concentration and participation during lessons. One teacher remarked, "Since the coolers were installed, I've seen fewer students missing school due to stomach issues. It has made a real difference in their ability to focus." The Parents too expressed appreciation for the initiative, noting that access to clean water alleviates their concerns about their children's health. A parent stated, "I feel more confident sending my child to school knowing they have safe water to drink."

community involvement and support are encouraged to foster a sense of ownership over the school.

5. Impact

The anticipated impact of the project includes increased enrollment rates, improved student performance, and enhanced community engagement in education. A well-constructed school facility is likely to motivate students and parents to prioritize education, leading to long-term benefits for the community.

Beneficiary Interaction Findings

Interactions with beneficiaries revealed:

- Students shared their enthusiasm for having a new, spacious environment conducive to learning.

Recommendations

- Awareness Campaigns: Implement community outreach programs to highlight the benefits of the new school facility and encourage parental involvement.
- Training Workshops: Organize professional development workshops for teachers to enhance their teaching methods and maximize the use of the new infrastructure.

The financial assistance for the construction of the school at Sree Krishna Vidyalaya Matric High School represents a significant investment in educational infrastructure in Alampadi, Tamil Nadu. The project has demonstrated its relevance, efficiency, effectiveness, and potential for sustainability. By addressing the identified gaps and following the recommendations, the initiative can further enhance its impact on educational quality and community development.

Recommendations and Conclusions

To improve the CSR projects across various thematic areas, the following recommendations have been developed. Each set of recommendations addresses specific gaps observed in the projects, covering areas like healthcare, education, infrastructure, and community development. These suggestions will aid to ensure comprehensive improvement and implementing them will ensure that RCF's CSR initiatives are sustainable, effective, and deliver long-term benefits to the communities they serve-

- 1. Strengthen Community Engagement: Increase engagement with local community leaders and beneficiaries during the project planning phase to ensure that projects are not just beneficial but also aligned with cultural and local priorities.
- 2. Improve Training for Field Staff: Address any skill gaps identified among field staff by providing them with more targeted training, particularly for projects involving technical or healthcare components
- 3. Combine Infrastructure with Awareness Programs: Combine physical infrastructure projects (e.g., water tanks, school buildings) with community awareness programs to ensure full utilization and engagement by the beneficiaries.
- 4. Enhance Collaboration with Local Authorities: Improve collaboration with local government bodies to address challenges quickly and streamline project implementation, especially in regulatory or licensing matters.
- 5. Enhance Project Management Processes: Implement better project management practices to reduce delays and cost overruns, such as using digital tools for tracking milestones and budget expenditure.
- 6. Standardize Procurement Procedures: Create standardized procurement processes to reduce time delays and improve cost efficiency, especially for projects involving the supply of materials or equipment.
- 7. Scale Successful Pilots: Identify small-scale projects that showed high success and look for ways to scale them to other locations, using the lessons learned to improve replication.
- 8. Develop Local Maintenance Committees: Form local committees to oversee the maintenance of facilities, like water supply systems or school buildings, ensuring their upkeep even after the project's end.

- 9. Introduce Financial Literacy Programs: For income generation projects, include financial literacy training to help beneficiaries manage their earnings and plan for sustained growth.
- 10. Strengthen Partnerships for Ongoing Support: Enhance partnerships with local NGOs, government agencies, and community organizations to ensure continued support and resource sharing even after the project's initial phase concludes.
- 11. Focus on Capacity Building: Invest more in training programs that build local capacities, such as training healthcare workers or educators, ensuring that the community can sustain the benefits of the project independently.
- 12. Create a Maintenance Fund for Key Infrastructure Projects: For projects like healthcare equipment or educational infrastructure, consider setting up a dedicated fund for future repairs or maintenance, ensuring these resources remain operational.
- 13. Adopt Environmentally Sustainable Practices: Ensure projects integrate environmentally friendly practices. For instance, water projects should focus on sustainable water management, and construction projects should use ecofriendly materials where possible.
- 14. Encourage Local Ownership Models: Wherever feasible, transfer ownership of projects to local community groups or cooperatives. This model encourages a sense of responsibility and ensures the project remains a community asset for years to come.
- 15. Establish Water User Committees: Form local water user groups responsible for the regular maintenance of water supply infrastructure, ensuring proper usage and upkeep.
- 16. Include Maintenance Funds in Project Budgets: Allocate a dedicated portion of the project budget for future repairs and maintenance, particularly for projects involving physical infrastructure like buildings and community centers.
- 17. Enhance Market Linkages: Form partnerships with local businesses, cooperatives, and e-commerce platforms to provide better market access for products created through livelihood initiatives, helping sustain income generation.
- 18. Conduct Environmental Awareness Workshops: Host community workshops focused on the importance of conservation, waste management, and sustainable practices, encouraging more eco-friendly behaviors.
- 19. Integrate Sustainable Practices Across Projects: Adopt environmentally friendly practices in all infrastructure projects, such as using solar energy, rainwater harvesting, and recycled materials. biodiversity.
- 20. Enhance Stakeholder Communication: Improve regular communication with stakeholders, including local authorities, community members, and employees of RCF, to keep them informed and engaged throughout the project lifecycle.

21. Create Sustainability Plans for Each Project: Develop clear sustainability plans for each project, outlining how they will be maintained and funded beyond the initial implementation period.

These recommendations aim to address the specific issues identified within the projects, fostering improved relevance, effectiveness, efficiency, impact, and sustainability across various CSR initiatives.

Specific Recommendations across Project Types

- Healthcare Projects: Regularly assess health indicators to determine improvements. Consider partnerships with local healthcare providers to enhance service delivery and training.
- Educational Initiatives: Track the improvement in educational metrics, such as enrollment rates, attendance, and academic performance. Ensure infrastructure projects like the construction of school buildings or provision of computers are accompanied by training for effective use.
- Water and Sanitation: Focus on creating awareness about hygiene practices along with providing infrastructure. This ensures that facilities like toilets, water coolers, and dustbins are used effectively and maintained properly.
- Women Empowerment and Livelihoods: Prioritize skill development and market linkages for projects that focus on women's income generation. Track increases in income and self-sufficiency levels.
