Rock phosphate other than the above sources will not be considered for regular order. However, Rock phosphate offered from any new source will be considered for trial order and on successful execution of trial order this new source will be also incorporated for future tenders.

Trial order/s: Any new source of Rock Phosphate meeting NIT specifications shall be considered only for trial purpose subject to price being competitive. The trial order quantity shall be of appropriate quantity which will be over and above the tender quantity. Considering small size cargo for trial purpose, co-shipment shall be permitted for trial order.

3.01 Mutually Agreed Damages on Account of Higher Moisture:

In the event the moisture content of the material loaded aboard the vessel is in excess of percentage moisture quoted by the bidder but is below 5% based on the analysis reports of the separate independent Inspection Agencies, appointed by RCF and supplier at load port, the consignment shall be accepted after deducting quantity equivalent to excess Moisture content over and above guaranteed Moisture from the BL quantity and invoicing on applicable CFR price.

In case moisture content is found to be higher than 5%, RCF shall have right to reject the consignment or accept at its sole discretion. However, in case RCF accepts the consignment at its

sole discretion, in such case the mutually agreed damage on account of excess moisture shall be after deducting quantity equivalent to **two times** the quantity of the excess Moisture over and above 5% from the BL quantity in addition to single time deduction for Moisture up to 5% as mentioned above.

The party shall invoice with adjusted quantity as stated aforesaid towards higher Moisture content and such rebate in quantity shall be invoiced on applicable CFR price.

3.02 Mutually Agreed Damages On Account Of Lower P₂O₅:

The price quoted shall be based on minimum P₂O₅ content offered on dry basis. In case the P₂O₅ content is found to be less than the offered minimum P₂O₅ and is not below 29% based on analysis reports submitted by separate independent inspection agencies, appointed by RCF and supplier at load port, **two times pro-rata rebate** in the invoice shall be given at the applicable CFR price.

(Example: If CFR price is US\$ 100 PMT for Rock Phosphate with guaranteed P₂O₅ content of 30% minimum and the actual P₂O₅ in the Rock Phosphate supplied is 29%, the prorata price for 29% shall work out to US\$ 96.66 PMT i.e., reduction of US\$ 3.34 PMT. Therefore, two times prorata rebate shall work out to US\$ 6.68 PMT).

In case P₂O₅ content is found to be below 29%, RCF shall have right to reject the consignment or accept at its sole discretion. However, in case RCF accepts the consignment at its sole discretion, in such case the mutually agreed damage on account of lesser P₂O₅ shall be equivalent to two times prorata rebate for P₂O₅ content lower than guaranteed percentage upto 29% **plus** five times prorata rebate for P₂O₅ content lower than 29% upto actual analyzed P₂O₅ percentage. The rebate shall be applicable on CFR price.

The party shall invoice RCF with the adjusted price after offering such rebate as stated aforesaid towards lower P₂O₅ content.

3.03 Mutually Agreed Damages on Account of Higher CaO:

The price quoted shall be based on maximum CaO content offered on dry basis. In case the CaO content is found to be higher than the guaranteed CaO content and is below 52% based on analysis reports submitted by separate independent inspection agencies appointed by RCF and supplier at load port, rebate shall be given in the invoice. For every 'X' % increase in CaO content over the guaranteed maximum CaO content, the rebate shall be '2X%' of the applicable CFR price.

(Example: If CFR price of Rock Phosphate is US\$ 100 PMT with guaranteed CaO of 49% maximum and the CaO content in the actual supply is found to be 50%, the rebate shall be 2% of CFR price i.e. US\$ 2 PMT).

In no case the CaO content shall be higher than 52%. In case CaO content is found to be above 52%, RCF shall have right to reject the consignment or accept at its sole discretion. However, in case RCF accepts the consignment at its sole discretion, in such case the mutually agreed damage on account of higher CaO shall be equivalent to rebate of '2X%' on the CFR price for every 'X%' increase in CaO content over the guaranteed maximum percentage upto 52% **plus** rebate of '5X%' on the CFR price for every 'X%' increase in CaO content above 52% upto actual analyzed.

3.04 Mutually Agreed Damages on Account of Deviation in Quality Other Than P₂O₅, CaO and Moisture:

In case any of the constituents other than P₂O₅, CaO and Moisture is found to be beyond the limits stipulated in NIT, based on the analysis reports of the separate independent Inspection Agencies, appointed by RCF and supplier at load port, RCF shall have right to reject the consignment or accept at its sole discretion. However, in case RCF accepts the consignment at its sole discretion, in such case the mutually agreed damage on account of any of the constituents found to be beyond maximum limits stipulated the consignment shall be accepted after deducting quantity equivalent to **two times** the quantity over and above the specified limits in the NIT of each constituent from the BL quantity and invoicing on applicable CFR price.

3.05 Justification For Suitability of Rock Phosphate Offered:

Tenderer should furnish along with the Part-I of the tender, justification for suitability of offered Rock Phosphate for production of Nitro phosphate (Suphala). The brief process details of Nitro-Phosphate 'Suphala' (15:15:15) is as given under:

Suphala Plant employing phosphor-nitric process comprising of a reaction and four salt section streams. Reaction bay is equipped with 3 reactor system and modified salt streams by incorporating 'KEMIRA PROCESS' of M/s Kemira O.Y. FINLAND. Pulverized Rock Phosphate, Nitric Acid, Sulphuric Acid, Di-Ammonium Phosphate (DAP) and vaporized Ammonia are allowed to react to form a slurry. Addition of Potassium Chloride is done in the 3rd reactor. The slurry thus formed is atomized and sprayed on to recycle bed in a granulator cum dryer called spherodizer. The product obtained after screening is cooled, coated and sent to storage.

Tenderers to note the following: Vessels chartered for discharge at MBPT (Hay Bunder) shall be handled in mid-stream at inner anchorage. Therefore, these vessels should be self-gear bulk carriers fitted with minimum **four** cranes of 25 MT SWL each with minimum outreach of 8.5 metres and suitable for Grab discharge (Crane should be able to serve all hatches & preferably having on board grabs). The vessel should be able to supply sufficient power to operate all cranes & loaded grabs simultaneously.
- 13.0 Analysis & Sampling:**
- 13.1. The analysis for RCF shall be made at RCF's expenses by any recognized laboratory appointed by RCF at load port.
- 13.2. RCF shall draw samples for determining the quality and for verification of the various constituents detailed under clause 3.00 of NIT. The representative composite sample shall be drawn in the customary manner during loading operations through inspection agency appointed by RCF.
- 13.3. The supplier, if so desires, can nominate their representative to supervise the Draft Survey and drawl of samples at their own expenses.
- 13.4. Samples drawn by inspection agency during loading operation shall be sealed in glass jars, two of which shall be sent to RCF with the Master of the vessel for delivery to RCF's nominees at port of discharge, two to be retained by RCF's representative appointed at load port for checking and analysis purpose and other two to be given to suppliers for reference. A certificate of sampling detailing destination of the samples shall be made out and signed by both the parties to the sampling process.
- 13.5. However, in case of contestation as regards any of the constituents, one of the samples retained by the RCF's representative or samples received through Master of the vessel shall be sent to a neutral body/agency or laboratory to be mutually agreed upon for umpire analysis. Results of the umpire analysis will be final and binding on both the parties and the cost for such analysis will be borne by the losing party i.e., party whose analysis differs from the umpire analysis more widely.
- 13.6. Inspection at Discharge Port:**
In case RCF does not appoint inspection agency at the load port, an independent inspection agency at discharge port will be appointed for inspection of the cargo, analysis of the samples and draft survey. The inspection agency shall draw six samples; two for RCF Ltd., two for representative of the supplier and two for umpire analysis to be retained by RCF. In such case, supplier shall depute their authorized representative to witness sampling and draft survey. The results thus obtained shall be final and binding on both the parties including rebates on account of excess moisture and lesser P₂O₅ as mentioned in clause 3.01 to 3.04 respectively.

13.7. RCF at its discretion may depute its representative at load port during loading operations to witness sampling and analysis of Rock Phosphate.

13.8. Bidder shall give minimum two intermittent Analysis Report giving actual P₂O₅ and moisture in the Rock Phosphate during ship loading at load port.

14.0 Weighment:

Weighment shall be as determined by draft survey conducted through an independent internationally reputed surveyor / inspection agency at the loading port appointed by RCF at RCF's cost.

15.0 The Supplier shall also appoint Internationally Reputed Inspection Agency at load port (other than that appointed by RCF) as per GTC Clause 11.03 for carrying out Inspection (Sampling, Analysis and weighment).

16.0 Payment Term:

The Payment Term shall be as per GTC Clause No.: 9.00. The LC shall be established on shipment-to-shipment basis on nomination of the vessel. In addition to the documents mentioned in GTC Clause No.: 9.00, the following documents shall also form part of LC documents:

- Certificate of Quality (Analysis Report) from independent inspection agency appointed by RCF.
- Certificate of Weight & Draft Survey Report from independent inspection agency appointed by RCF.
- Certificate of Quality from independent inspection agency appointed by Supplier.
- Certificate of Weight & Draft Survey Report from independent inspection agency appointed by Supplier.
- Certificate of Origin issued by local Chamber of Commerce/ Industry mentioning the name of the Producer as declared by the bidder at the time of tender.

The shipment value shall be calculated as per PO terms based on the reports of both the Inspection Agencies as mentioned above. The shipment value thus calculated, whichever is less, shall be considered for invoicing / payment purpose.

17.0 Operation Of Contract:

- a. In order to consider operation of the contract on FOB basis, supplier shall provide lay can and name of load port as per the agreed shipment schedule ensuring the readiness of cargo during the provided laycan.
- b. After receipt of laycan and load port, RCF shall send communication either nominating suitable vessel for operating contract on FOB basis OR for supply on CFR basis.
In case of FOB, after nomination of vessel by RCF, the supplier shall not be allowed to change port of loading and laycan.
- c. On receipt of communication from RCF for supply on CFR basis, supplier to nominate suitable vessel and ship the cargo within the contractual shipment period.

The shipment period mentioned in the NIT clause No.12.01 shall include all the above activities. However, grace period, if any as mentioned above at b) & c) shall be in addition to the shipment period mentioned in the NIT clause No. 12.01

18.0 With reference to Notification No. F.No. 6/18/2019-PPD dated 23.07.2020 issued by Department of Expenditure, Ministry of Finance, Govt. Of India the following may be noted: (Annexure-L)

4. Transgression Clause:

4.1 Transgression will mean instances of fraud, corruption, bribery, collusion, or any other unethical or illegal activities that a bidder or its personnel have been involved in.

Transgression for the purpose of the Integrity Pact shall mean and include any transgression that has occurred at any time within the past 3 (three) years reckoned from the submission of the bid.

4.2 Disclosure of Transgressions:

5. Sanctions for violations:

- vii. To debar/blacklist the BIDDER from participating in future bidding processes of RCF for a minimum period of five years, which may be further extended at the discretion of RCF.
 - viii. To recover all sums paid, in violation of this Pact by BIDDER to any middleman or agent or broker, with a view to securing the contract.
 - ix. In case where irrevocable Letters of Credit have been opened in respect of any contract signed by RCF with the BIDDER, the same shall not be operated.
 - x. Forfeiture of Performance Bond in case of a decision by RCF to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
 - xi. Consequences of Non-Disclosure: In the event that Bidders fail to disclose any relevant past instances of fraud, corruption, bribery, collusion, or any other unethical or illegal activities within the stipulated timeframe, it shall be considered a material breach of this Integrity Pact. RCF reserves the right to invoke disqualification of the bidders and exclusion from future business dealings and take such actions, as per the existing provisions of GFR, 2017, Prevention of Corruption Act, 1988 and other Financials Rules/Guidelines etc. as may be applicable to RCF against the Bidders, as deemed appropriate.

- 6.2 The task of the Monitor shall be to review independently and objectively, whether and to what extent the parties comply with the obligations under this Pact.
- 6.3 The Monitor shall not be subject to instructions by the representatives of the parties and perform his functions neutrally and independently.
- 6.4 Both the parties accept that the Monitor has the right to access all the documents relating to the project/ procurement, including minutes of meetings. A summary of procurement/contract awarded, which are covered under the IP shall be shared by RCF with the IEMs on quarterly basis. However, the documents / records/ information having National Security implications and those documents which have been classified as Secret / Top Secret are not to be disclosed. In the event of any dispute between the RCF and the contractor relating to those contracts where integrity pact is applicable, dispute will be first referred to the panel of IEMs with both parties consenting, and the IEMs will try to resolve the dispute in a time bound manner. In case, the dispute remains unsolved even after mediation by the panel of IEMs, RCF may take further action as per the terms and conditions of the contract. The expenses incurred for holding meeting of IEMs for dispute resolution will be shared equally by the RCF and the Contractor/Bidder. Bidder signing Integrity Pact shall not approach the Court while representing the matters to IEM and bidder will await their decision in the matter.
- 6.5 As soon as the Monitor notices, or has reason to believe a violation of this Pact, he will so inform the Authority designated by RCF.

ANNEXURE-J

Debarment of firms from Bidding (Holiday/De-listing/Black-listing)

1. Debarment is classified under following two types:

(i) In cases where debarment is proposed to be limited to only RCF, the appropriate Orders can be issued by RCF, thereby banning all its business dealing with the debarred firm.

(ii) Where it is proposed to extend the debarment beyond the jurisdiction of RCF i.e., covering to all central Ministries/ Departments, the requisite Orders shall be issued by Department of Expenditure (DoE), Ministry of Finance (MoF).

Definitions

2. Firm: The term 'firm' or 'bidder' has the same meaning for the purpose of these Guidelines, which includes an individual or person, a company, a cooperative society, a Hindu undivided family and an association or body of persons, whether incorporated or not, engaged in trade or business.

3. Allied firm: All concerns which come within the sphere of effective influence of the debarred firms shall be treated as allied firms. In determining this, the following factors may be taken into consideration:

- Whether the management is common;
- Majority interest in the management is held by the partners or directors of banned/ suspended firm;
- Substantial or majority shares are owned by the banned/ suspended firm and by virtue of this it has a controlling voice.
- Directly or indirectly controls, or is controlled by or is under common control with another bidder.
- All successor firms will also be considered as allied firms.

4. The terms "banning of firm", 'suspension', 'Black-Listing' etc. convey the same meaning as of "Debarment".

Debarment by RCF, limited to only RCF-

5. Orders for Debarment of a firm(s) shall be passed by RCF, keeping in view of the following:

a. A bidder or any of its successors may be debarred from participating in any procurement process for a period not exceeding two years.

b. Firms will be debarred if it is determined that the bidder has breached the code of integrity as per Rule 175 of GFRs 2017 given below-

No official of a procuring entity or a bidder shall act in contravention of the codes which includes

(i) prohibition of

(a) making offer, solicitation or acceptance of bribe, reward or gift or any material benefit, either directly or indirectly, in exchange for an unfair advantage in the procurement process or to otherwise influence the procurement process.

(b) any omission or misrepresentation that may mislead or attempt to mislead so that financial or other benefit may be obtained or an obligation avoided.

(c) any collusion, bid rigging or anticompetitive behavior that may impair the transparency, fairness and the progress of the procurement process.

(d) improper use of information provided by the procuring entity to the bidder with an intent to gain unfair advantage in the procurement process or for personal gain.

- (e) any financial or business transactions between the bidder and any official of the procuring entity related to tender or execution process of contract; which can affect the decision of the procuring entity directly or indirectly.
- (f) any coercion or any threat to impair or harm, directly or indirectly, any party or its property to influence the procurement process.
- (g) obstruction of any investigation or auditing of a procurement process.
- (h) making false declaration or providing false information for participation in a tender process or to secure a contract;
- (ii) disclosure of conflict of interest.
- (iii) Disclosure by the bidder of any previous transgressions made in respect of the provisions of sub-clause (i) with any entity in any country during the last three years or of being debarred by any other procuring entity.

c. A bidder can also be debarred for any actions or omissions by the bidder other than violation of code of integrity, which in the opinion of RCF, warrants debarment, for the reasons like supply of sub-standard material, non-supply of material, abandonment of works, sub-standard quality of works, failure to abide "Bid Securing Declaration" etc.

d. Before issuing the debarment order against a firm, reasonable opportunity shall be given to the concerned firm to represent against such debarment (including personal hearing, if requested by firm).

e. List of debarred firms will be maintained, which will also be displayed on RCF's website for all units of RCF.

6. Similarly, Government e-Marketplace (GeM) can also debar bidders upto two years on its portal as per their rules for GeM portal hence these debarred firms will not be eligible to participate in RCF's tenders in GeM only.

Debarment across All Ministries /Departments / Other PSUs (State as well as Centre)/ Departments/ Central Public Sector Undertakings (CPSUs)/ State Public Sector Undertakings

7. Where RCF is of the view that business dealings with a particular firm should be banned across all the Ministries/ Departments, RCF can forward such debarment proposal to DoE through DoF. DoE may issue the necessary orders after satisfying itself that proposed debarment across all the Ministries/ Departments is in accordance with Rule 151 of GFRs, 2017. Rule 151 of GFRs, 2017 is given below-

A bidder shall be debarred if he has been convicted of an offence— (a) under the Prevention of Corruption Act, 1988; or (b) the Indian Penal Code or any other law for the time being in force, for causing any loss of life or property or causing a threat to public health as part of execution of a public procurement contract.

(A bidder debarred under sub-section (i) or any successor of the bidder shall not be eligible to participate in a procurement process of any procuring entity for a period not exceeding three years commencing from the date of debarment. Debarment of commerce (DGS&D) will maintain such list which will also be displayed on the website of DGS&D as well as Central Public Procurement Portal.

A procuring entity may debar a bidder or any of its successors, from participating in any procurement process undertaken by it, for a period not exceeding two years, if it determines that the bidder has breached the code of integrity. The Ministry/Department will maintain such list which will also be displayed on their website.

The bidder shall not be debarred unless such bidder has been given a reasonable opportunity to represent against such debarment.

8. The firm will remain in suspension mode (i.e. debarred) during the interim period till the final decision taken by DoE, only in RCF.
9. Before forwarding the debarment proposal to DoE through DoF, reasonable opportunity shall be given to the concerned firm to represent against such debarment (including personal hearing, if requested by firm).
10. DoE can also give additional opportunity, at their option, to firm to represent against proposed debarment. DoE can also take suo-moto action to debar the firms in certain circumstances.
11. No contract of any kind whatsoever shall be placed on the debarred firm, including its allied firms by RCF after the issue of a debarment order.
12. DoE will maintain list of such debarred firms, which will be displayed on Central Public Procurement Portal.

Revocation of Orders

13. An order for debarment passed shall be deemed to have been automatically revoked on the expiry of that specified period and it will not be necessary to issue a specific formal order of revocation.
14. A debarment order may be revoked before the expiry of the Order, by the competent authority of DoE, if it is of the opinion that the disability already suffered is adequate in the circumstances of the case or for any other reason.

Other Provisions (common to both types of debarments)

15. No contract of any kind whatsoever shall be placed to debarred firm including its allied firms after the issue of a debarment order by competent authority. Bids from only such firms shall be considered for placement of contract, which are neither debarred on the date of opening of tender (first bid, normally called as technical bid, in case of two packet/two stage bidding) nor debarred on the date of contract. Even in the cases of risk purchase, no contract should be placed on such debarred firms.
16. If case, any debar firms has submitted the bid, the same will be ignored. In case such firm is lowest (L-1), next lowest firm shall be considered as L-1. Bid security submitted by such debarred firms shall be returned to them.
17. Contracts concluded (awarded) before the issue of the debarment order shall, not be affected by the debarment Orders.
18. The Debarment shall be automatically extended to all its allied firms. In case of joint venture/ consortium is debarred all partners will also stand debarred for the period specified in Debarment Order. The names of partners should be clearly specified in the "Debarment Order".
19. Debarment in any manner does not impact any other contractual or other legal rights of the procuring entities.
20. The period of debarment shall start from the date of issue of debarment order.
21. The Order of debarment will indicate the reason(s) in brief that led to debarment of the firm.

ANNEXURE-K

Compliance with Goods and Services Tax (GST)

1. Vendor/Supplier/Contractor shall submit documents related to GST Registration such as GST Registration certificate/certificates active as on date of participation in the tender and also supporting documents if the Vendor/Supplier/Contractor /Contractor is registered under Composition Scheme. If unregistered under GST, give a declaration to that effect.
2. Vendor/Supplier/Contractor shall notify the company if it ceases at any time to be registered under GST and also if obtains a new GST registration.
3. If Vendor/Supplier/Contractor is having multiple GST registrations, should intimate the company from which GSTIN invoices will be preferred.
4. Vendor/Supplier/Contractor shall submit the periodicity of filing GST returns applicable to him.
5. Vendor/Supplier/Contractor shall intimate the company about applicability of e-invoicing, SAC /HSN codes for the goods /services supplied by him along with the applicable GST rate as on date of participation in tender. If due to any subsequent amendment/notification under GST Act, there is any change in the tax rates; vendor shall update the company for the same by submitting such notification.
6. Vendor/Supplier/Contractor /Contractor shall ensure timely submission of Invoice(s)/ Bill of Supply /Receipt Voucher or any other document as per rules/ regulations of GST Act with all required supporting document(s) within a period specified in Contracts/ LOA.
7. Vendor shall submit separate invoices for services rendered based on company's request for necessary compliance under GST as the case may be.
8. The vendor undertakes to file all required Returns, deposit taxes and details required to be submitted under GST laws & rules as per due dates prescribed. The vendor also agrees to do all things including providing invoices or other documentation in such form and detail that may be necessary to enable or assist the company to claim or verify any Input Tax Credit, set off, rebate or refund in relation to any GST payable under the Agreement entered/Work Order/Purchase Order
9. All necessary adjustment vouchers such as Credit Notes / Debit Notes for any short/excess supplies or revision in prices or for any other reason under the Contract shall be submitted to the company as per GST Act provisions.

12. The company reserves a right to review the Vendor/ supplier invoices to ensure that they are GST compliant and in case of any discrepancy observed, the supplier shall arrange to submit tax compliant invoice, only upon which payment shall be processed.
13. Vendor/Supplier/Contractor would promptly pay GST for the supplies made to the company and would upload returns within the prescribed time as per GST Act.
14. In the event of default on his part in payment of tax and submission / uploading of monthly returns, the company is well within its powers to withhold payments, especially the tax portion, until Vendor/Supplier/Contractor corrects the default /gets the shortcomings rectified at his own cost and / or complies with the requirements of GST Act and produces satisfactory evidence to that effect or upon invoice /debit note/credit note appearing in GSTR2A of the Company on the GST portal.
15. In case GST credit is delayed/ denied to the company and reversed subsequently as per GST law, due to non/delayed receipt of goods and/or services and/or tax invoice or expiry of timeline prescribed in GST Law for availing such ITC, non-payment of taxes or non-filing of returns or any other reason not

- attributable to the company, GST amount shall be recoverable from Vendor/Supplier/Contractor along with interest levied/ leviable on the company by GST authority.
16. In the event of delay in getting ITC to the company due to reasons attributable to the Vendor/Supplier/Contractor, the company reserves the right to recover interest at 12% on the tax credit so available for the number of days the ITC was delayed. In case of receiving any notice / intimation from GST authority to the company towards non-compliance by the vendor, payments will be withheld for all outstanding bills and bills received subsequently from the vendor, till the time, necessary rectification has been carried out by the vendor and proof of the same has been submitted to the company.
 20. Any late delivery i.e., delivery after the due date or delay in submission of invoices or any other delays, attracts payment of damages by the vendor / contractor as agreed mutually. It is agreed by the vendor/supplier /Contractor that such damages become recoverable by the company with applicable GST thereon.
 21. In case the GST rating of vendor on the GST portal / Govt. official website is negative / black listed, then the bids may be rejected by the company. Further, in case rating of bidder is negative / black listed after award of work for supply of goods / services, then the company shall not be obligated or liable to pay or reimburse GST to such vendor and shall also be entitled to deduct / recover such GST along with all penalties / interest, if any, incurred by the company.
 22. The company reserves the right to suspend / cancel / terminate the contract in the event of frequent / multiple / repeated defaults by the Vendor/Supplier/Contractor in complying with the requirements as per GST Law and Vendor/Supplier/Contractor shall be put under Holiday list as mentioned in the Contract.

ANNEXURE-I

Restrictions under Rule 144 (xi) of the General Financial Rules (GFRs), 2017 (OM no. 6/18/2019-PPD dated 23rd July 2020)

I. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. The Competent Authority for the purpose of registration under this Order shall be the Registration Committee constituted by the Department for Promotion of Industry and Internal Trade (DPIIT)*.

II. "Bidder" for the purpose of this Order (including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated herein before, including any agency branch or office controlled by such person, participating in a procurement process.

"Tender" for the purpose of this Order will include other forms of procurement, except where the context requires otherwise.

III. "Bidder from a country which shares a land border with India" for the purpose of this Order means: -

- a. An entity incorporated, established or registered in such a country; or
- b. A subsidiary of an entity incorporated, established or registered in such a country; or
- c. An entity substantially controlled through entities incorporated, established or registered in such a country; or
- d. An entity whose beneficial owner is situated in such a country; or
- e. An Indian (or other) agent of such an entity; or
- f. A natural person who is a citizen of such a country; or
- g. A consortium or joint venture where any member of the consortium or joint venture falls under any of the above

IV. The beneficial owner for the purpose of (iii) above will be as under:

1. In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.

Explanation-

- a. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent. of shares or capital or profits of the company;
- b. "Control" shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreements or voting agreements;
2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;

4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official;
5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- V. An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
- VI. Certificate regarding compliance

Bidder shall furnish a certificate along with tender documents regarding their compliance with this Order as per the format on their letter head. If such certificate given by a bidder whose bid is accepted is found to be false, this would be a ground for immediate termination and further legal action in accordance with law.

Format of Certificate

"I have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; I certify that this bidder is not from such a country or, if from such a country, has been registered with the Competent Authority. I hereby certify that this bidder fulfills all requirements in this regard and is eligible to be considered. [Where applicable, evidence of valid registration by the Competent Authority shall be attached.]"

VII. Validity of registration

Registration should be valid at the time of submission of bids and at the time of acceptance of bids-

- VIII. The said order will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

Updated lists of countries to which lines of credit have been extended or in which development projects are undertaken are given in the website of the Ministry of External Affairs.
