On acceptance of the Tender by RCF, for due and faithful fulfillment of the contract, t he Successful Tenderer shall furnish to RCF, Security Deposit for an amount of 5% of basic contract value either in the form of bank guarantee as per RCF's format or thro ugh RTGS/NEFT towards faithful performance of the contract within 21 days of receip t of work order/LOI. **Bank guarantee shall be valid for the period of 30 months** (24 Months WO validity+ 6 Months Guarantee) + 60 days from date of plac ement of Work Order.
