SCOPE OF WORK

The scope of work includes the following.

- Comprehensive maintenance of P.A. system including regular inspection, preventive and corrective maintenance of system and other associated equipment's.
- The party should ensure trouble free operation of the system consisting of the equipment's as listed below.
- Incoming power supply for the units and replacement of interconnecting cables to the field stations, speakers are excluded.
- The scope includes replacement of defective parts, faulty control PCB'S, fuses, switches, components etc. in the system as may be necessary to maintain the P.A. system efficiently during contract period with new parts (Not repaired parts).
- Check all distribution field wiring and containment. Check to ensure that all leads are plugged in firmly into correct connectors which should also be tightened if found loose.
- Ensure sound quality is good and free from crackling.
- The quality of sound on each speaker shall be checked to the entire satisfaction of user with their certification.

- h) The speech intelligibility of the system shall be maintained to good levels
- i) The authorized servicemen should visit the site once in a fortnight and carry out servicing and preventive maintenance as required. Also he should carry out checking & testing of each station and submit the reports against the same.
