If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within $L-1+ 15\%$ of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

SCOPE OF WORK

- 1) The Man power of Skilled Electricians and un-skilled labours are required as & when required basis and during the shutdown, breakdowns situation. The manpower shall be required in all shifts including Sundays and Holidays. The job includes providing temporary connections, cable laying, cable terminations, Light fitting provis

ions etc. at all locations of the plant and assisting in maintenance of motors, switchboards etc. Electrician shall have required tools with them for carrying out the jobs.

- 2) During shut down /breakdown party has to mobilise man power in short notice as per requirement given by RCF Engineer. The shutdown / breakdown period may be two or more times in a year for one week or up to one month duration in various plants in a year.
- 3) All electricians shall be technically experienced person with relevant certificate of education related to Electrical field. The contractor shall employ only qualified worker on all the jobs.
- 4) Adequate manpower shall be arranged by the contractor without break in services i.e. including SUNDAY & HOLIDAY. Electrician should not leave the site without completion of the duty.
- 5) Payment will be made as per actual quantity executed.
- 6) Actual date of requirement of man power will be intimated 4-7 days in advance.
- 7) Medical help provided at site shall be limited to First Aid only.
- 8) Party shall submit the invoice in three copies plant wise.
- 9) The contractor shall arrange tools like plier, screw driver, tester etc.
- 10) Contractor has to give minimum wages payment to the engaged manpower as per declared by government. The contractor has to make salary of workers up to 7th day of next month. The contractor shall deposit monthly P. F. contributions and ESIC contributions, within 15 days of the end of every calendar month.
- 11) The bills of the contractor will be certified and passed for payment only after production of HR clearance NOC.
- 12) Following are the current payment of revised minimum wages w.e.f. 01.07.2025 declared by state Govt.
 - i. Skilled: Rs.865.23/- per day (Basic + DA)
 - ii. Un-Skilled: - Rs.765.69/- per day (Basic + DA)During quote, bidder shall consider the above minimum wages payment plus contribution towards PF@13% + ESIC@3.25%/INSURANCE + BONUS @8.33% of Basic & DA + Overhead charges of 3.30%.
- 13) Also note that every six months there will be revision of minimum wages, that cost shall be bear by bidders itself. Bidder shall pay the revised payment to the workers at every time.
- 14) The tenure of contract shall be one year from the date of issue of work order.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
