LETTER INVITING PRICE BIDS

Sub :- Inviting quotation through single stage bidding in GEM for transportation of approximate 200 MT of Nano Urea by Road from Trombay Factory to various blocks of Maharashtra.

Dear Sir/Madam ,

As per the requirement, we hereby invite most competitive price bids for transportation of around 200 Mts of Nano Urea (each 500 ml Nano Urea bottle , packed in boxes of 24 bottles in each box, with each box weighing 16 kg.) from our Trombay Factory to various blocks of Maharashtra .

Box Dimensions and Sample Availability – RCF Nano Urea box

The dimensions of each box are as follows:-

Length x Width x Height – 400 mm x 270 mm x 220 mm

(A sample box has been placed at the RCF Trombay Gate Office for reference. You may inspect it during working hours.)

You are requested to use the enclosed form for submitting the quotation.

- 1.0** All the three pages of this LETTER INVITING PRICE BIDS to be submitted in GEM along with quotation.
- 2.0** Rates quoted should be in Rs per Mt. on flat rate basis.
- 3.0** Contract shall be awarded on lowest quote L-1 basis after rate negotiations if required to the bidder who has agreed for scope of work and all terms & conditions given in Tender documents.

4.0 GST on transportation will be paid by RCF as per applicable rates under Reverse Charge Mechanism

- 5.0** You will be required to submit price bids on GEM portal only. It is mandatory to quote for all the blocks mentioned in PRICE BEED SHEET.
- 6.0** The material will be loaded at RCF's respective loading points at Trombay Factory, Loading arrangements will be done by RCF Ltd.
- 7.0** Unloading will be done by RCF through godown contractors. No detention charges are payable. Unloading will be done in all working days between 10 a.m. and 5 p.m.
- 8.0** The scope of work shall include transportation of loaded material from Trombay factory to various blocks of Maharashtra within 3 days from the date of dispatch by deploying proper vehicle with provision for covering material to be transported.
- 9.0** It would be the sole responsibility of the contractor to ensure that the acknowledgement for the receipt of goods from the consignee is obtained on the Delivery Challan (OBD)/ Invoice /E-Way Bill and submitted to the consignor within 30 days from the date of dispatch of material as a written confirmation of delivery of the material. In case of non-delivery of material or delivery of the material in damaged condition due to the reasons attributable to the contractor, the company / consignor is entitled to recover the full value of material not delivered or delivered in damaged condition. The payment will be released within 30 days of successful completion of the job and submission of bill along with acknowledgement of Material .
- 10.0** The successful tenderer shall ensure that the material handed over to them is delivered in full , without transshipment at destination without any damage either to the material or to the packing, without use of hooks and within **3 days** from the date of loading at Trombay factory.
- 11.0** Acceptance of offer rests with RCF and it is not obligatory, in case of rejection, to assign any reason thereof.
- 12.0** No guarantee for work is given for which rate bids (quotations) are called, Quantity is tentative . RCF reserves the right to cancel all or part orders as deemed fit without assigning any reason whatsoever.
- 13.0** Penalties deviations if any will be as per the respective clause mentioned in NIT.
- 14.0** Transporter has to ensure compliance of all relevant labour laws applicable to Driver, cleaner or any other person entering our factory premises with the vehicle. Transporter will also adhere to the rules and regulations of RCF.
- 15.0** No other material should be loaded in the vehicle.
- 16.0** Detention will not be payable.
- 17.0** The transporter will have to take utmost care of the consignment, like fastening it suitably, avoid jerky movement of the vehicle, etc., so that the

consignment does not slide or rattle in transit, there is no damage to RCF cargo or to any other public property.

18.0 Transporter should ensure compliance of all applicable RTO norms.

19.0 Any deviation in the specification / terms and conditions will be summarily subject to disqualification.

20.0 Submit duly filled, signed and stamped copy of all four pages of **LETTER INVITING PRICE BIDS** with signature on each page.

21.0 Any deviation in the specification /terms and condition will be summarily subject to disqualification.
