Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1\\_4\\_2021\\_PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GEM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

### 1. Buyer Added Bid Specific ATC

Pre-qualification Criteria:

1) Past work experience:

i. Bidder for the subject tender shall have executed the job of fabrication (cutting and welding) of pipes of minimum 39mm thickness in MOC- Alloy Steel( Gr. P11 or Gr. P22) in reputed fertilizer/chemical/petrochemical/oil and gas/refinery/power plants. Submitted PO /WO shall be issued and executed during the last seven years ending the last day of month previous to the one in which this subject tender is floated/issued.

ii. Bidder should have and shall submit valid minimum Class-I Certificate (Regulation-392 of Indian Boiler Regulation) for Boiler repair and Pipeline Fabrication issued by Directorate of Steam Boiler.

iii. Proof of execution of submitted work order issued directly by subject fertilizer/chemical/petrochemical/oil and gas/refinery/ power plant, which may include any of the following -

(i) Completion Certificate / Customer Acceptance Certificate OR

(ii) GeM CRAC (Consignee Receipt and Acceptance Certificate) document

OR

(iii) (a) Tax Invoice to the extent of the required Pre-Qualification value and

(b) Proof of receipt of payment like bank statement for the above referred tax invoice.

OR

(iv) Any other document indicating work completion

2) Average annual financial turnover during the last three years, ending 31st March of the previous financial year (i.e. FY 2022-23, 2023-24 & 2024-25) should be at least Rs. 13.63 Lakhs.

In case the date of constitution/incorporation of the bidder is less than three years old, the average annual financial turnover in respect of the completed financial years after the date of constitution shall be taken into account. In this case, the financial turnover during last financial year/ the average financial turnover during preceding two financial years should be at least Rs. 13.63 Lakhs.

Bidders shall submit CA certificate / CA audited Profit & Loss accounts, Balance sheets etc. indicating the annual turnover figures, in support of the same. The financial documents has to be CA audited/issued with membership number, seal, signed and with UDIN.

3) Ownership of company with name, addresses and telephone nos. of proprietors/ partners/directors.

4) Copy of Partnership deed /proprietorship/ Memorandum and article of association and certificate of incorporation as the case may be.

5) Bidders have to submit the Net worth certificate of last three financial years issued by CA with membership number, seal, signed and with UDIN or CA audited financial statements/balance sheets for each of the last three financial years.

The net worth should not be negative in the balance sheet of last financial year (i.e. net worth should not be negative on 'The Relevant Date').

AND

The Net worth of Bidder should have not eroded by more than 30% in the last three years, ending on 'The Relevant Date'. It means the net worth of last financial year should not be less than 70% compared to the 3rd last financial year.

In case, the date of constitution/ incorporation of the bidder is less than 3 years old, the following will be applicable -

- The net worth in each of these years should not be negative
- Net worth in respect of the immediate previous financial year should not have eroded more than 30 percent than that of its previously audited financial statement. In case the bidder has completed financial statements of only preceding year, the clause of net worth erosion will not be applicable.
