<p>VIBRATION ANALYSIS OF PROCESS AIR COMPRESSOR-III IN AMMONIA PLANT, AT RCF THAL, FOR ONE YEAR.</p>

1. Background -

In Ammonia plant, Process air compressor- III is one of the most critical machine and supplies air for process requirement. It is turbine driven machine and having online vibration monitoring system. The OEM of online vibration monitoring system of PAC-III compressor is M/s Bently Nevada.

Whenever there is problem of high vibrations in PAC-III compressor, it is required to carry out vibration data analysis to pin-point the exact cause of vibrations. The vibration analysis is to be done as and when required and is to be carried out by OEM of vibration monitoring system.

A. Scope of Work for Vibration analysis -

- 1) RCF shall convey the date of data collection of vibrations to the contractor well in advance.
- 2) Contractor has to depute Engineer to collect vibration data of Process air compressor III at RCF Thal site with all necessary vibration analysis instruments with them.
- 3) Contractor shall arrange for connection of an ADRE 408 measuring system to the BN 3500 on plant site.
- 4) Contractor shall record and save measuring data during operation of the machine.
- 5) Contractor shall evaluate the measured data and generate standard required plots of vibration analysis as follows: -
 - a) Vibration amplitude, phase Vs Time plots
 - b) Bode plots
 - c) Full spectrum cascade/ waterfall diagrams
 - d) Shaft centerline plots
 - e) Polar plots
 - f) Frequency/ spectrum plots
 - g) Orbit and time base plots
6. Contractor shall carry out Initial vibration analysis and assessment of measured data with regards to anomalies.
7. Contractor shall co-ordinate with specialists from M/s Everllence India Private Limited, OEM of PAC-III compressor.
8. If necessary, additional vibration measurement shall be taken after consultation with M/s Everllence India Private Limited.
9. Contractor shall prepare vibration analysis reports with contents of point no. 4, 5 and 6 of the scope of work.
10. Contractor shall transfer all vibration data of PAC III to M/s Everllence India Private Limited
11. Contractor shall also carry out following analysis/ data collection: -
 - a) Startup/ shutdown transient no load and load data/trends capturing, analysis and submission of detail diagnosis analysis report to us along with recommendations
 - b) Measurement of vibration levels of bearing pedestals/ support structure around the steam turbine with portable vibro-port simulate with rotor shaft vibration levels
 - c) Natural frequency test of parts like stator parts/structure around and rotor.

12. Contractor to bring machinery of vibration analyzer having more than 20 channel inputs for displacement inputs.
13. Boarding is in the scope of the contractor.
14. The Engineer shall collect all the data of the equipment during one day.
15. After collection of the data, contractor shall carry out detailed vibration analysis at their end.
16. After data analysis, the contractor shall submit detailed reports along with all the recommendations within three days.

B. RCF's SCOPE:

1. RCF will arrange To & Fro Air ticket and pick up drop from Mumbai Airport.
2. RCF will provide Lodging of Service engineer at RCF Swagat Guest House,
3. Local Transport of Service Engineer is in RCF Scope including pick up & drop from Mumbai Airport.
4. Electrical supply is in RCF Scope.

C. GENERAL Terms and conditions

1. Contractor shall arrange all equipment and accessories required for complete vibration analysis.
2. All safety precautions shall be strictly followed by the contractor's manpower during the entire job.
3. Contractor shall arrange PPE'S to their employee while working at site.
4. Payment shall be made as per actual.
- 5. Mobilization time shall be 7 days.**

D. VALIDITY OF WORK ORDER:

1. Validity of work order shall be (01) One year from the date of issue of WO.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
