3. The Bidders shall submit successfully completed/carried out "railway track maintenance annual rate contract work", during the last seven years ending the last day of month previous to the one in which this subject tender is floated/issued and should be fulfilling, either of the following:

**Minimum value of work must be as follows:**

Three similar completed works each costing not less than the amount equal to Rs.11.53 Lakhs.

**OR**

Two similar completed works each costing not less than the amount equal to Rs. 14.42 Lakhs.

**OR**

One similar completed work each costing not less than the amount equal to Rs.23.06 Lakhs.

Proof of execution of submitted work order, vendor shall submit any of the following -

(i) Completion Certificate / Customer Acceptance Certificate OR

(ii) GeM CRAC (Consignee Receipt and Acceptance Certificate) document OR

(iii) (a) Tax Invoice to the extent of the required Pre-Qualification value and

(b) Proof of receipt of payment like bank statement for the above referred tax invoice OR

(iv) Any other document indicating work completion.

(v) The document submitted as proof of execution must be specifically for the same concerned Purchase Order (PO)/Work Order/Contract submitted, clearly indicating the corresponding PO/Work Order/Contract number.

2) Average annual financial turnover during the **last three years**, ending 31<sup>st</sup> March of the previous financial year (i.e. FY 2022-23, 2023-24 & 2024-25) should be **at least**

**Rs. 8.64 Lakhs.** (Based on 30% of basic estimated cost).

In case the date of constitution/incorporation of the bidder is less than three years old, the average annual financial turnover in respect of the completed financial years after the date of constitution shall be taken into account. In this case, the financial turnover during last financial year/ the average financial turnover during preceding two financial years should be **at least Rs.8.64 Lakhs.**

Bidders shall submit CA certificate / CA audited Profit & Loss accounts, Balance sheets etc. indicating the annual turnover figures, in support of the same. The financial documents has to be CA audited/issued with membership number, seal, signed and with UDIN.

The net worth of the Bidder firm should not be negative on 'The Relevant Date'. It means the net worth of the Bidder should not be negative in the balance sheet of last financial year.

Net Worth of bidder should not have eroded by more than 30% (thirty percent) in the last three years, ending on 'The Relevant Date'. **It means the net worth of last financial year should not be less than 70% compared to the 3rd last financial year.**

In case the date of constitution/ incorporation of the bidder is less than 3 years old, the following will be applicable:

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
