This Bid provides for Trade Receivables Discounting System (TReDS) as Preferred mode of payment. 1. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

SCOPE OF WORK

The scope of work for oil testing shall be as below.

1. Collection & Transportation of Transformer Oil/gas sample.
The Contractor shall collect the Transformer oil/gas sample from RCF Thal site, Kurul and Kihim Township. It will be responsibility of the Contractor to transport transformer oil sample in approved manner from Thal site to location of oil testing laboratory. The Contractor has to arrange air tight, chemically clean sampling bottles cylinders for collection of oil and gas samples in order to avoid any atmospheric contact with oil.
2. Contractor has to carry out the test on oil samples for impurities and dissolved gas contents, breakdown voltage, sludge content, acidity, viscosity, moisture contents, tan delta, interfacial tension, flash point etc. **All party has to carry out Furan analysis of transformer oil as per IEC 61198-1993.** All test may be done in accordance with BIS specifications and its latest amendment. The tests to be carried out on the samples drawn from bottom/top of the transformers and as instructed by the Engineer-in-Charge.
3. This is an ISO 9000-2000 requirement. The party shall submit valid Calibration Certificates of the test instruments used to carry out the tests on oil. RCF being ISO 9001, 14001 & 18001 certified company hence all the safety precautions must be followed strictly & use of personal protective equipment such as helmet etc. is mandatory.
4. Contractor has to use different bottles, container for top and bottom samples as per requirement of Engineer-In-Charge.
5. Contractor has to arrange for air tight cylinders for collecting the samples for testing impurities and gas contents to avoid any atmospheric contact with samples.
6. Contractor's bills will be paid after submission of test report for the test carried out and to the satisfaction of Engineer-In-Charge.
7. In case of emergency party has to collect few samples within 24 hours urgently submit the test reports.
8. **INSPECTION**
All tests conducted by the Contractor shall subject to inspection by RCF Engineer. Any test not meeting the specific requirements will be rejected and the Contractor shall retest the same immediately with test of specific type and quality. Contractor's testing procedure shall also be subject to inspection by RCF Engineer.

The party shall submit the Test reports for all the samples tested with their comments for various parameters/quality of Oil indicating the allowable lower / upper limits as per IS.

Wherever the Oil sample is not collected / handled properly resulting poor result shall be retested without extra cost.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of

Single Bid / Proprietary Article Certificate (PAC) Buying.

3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
