Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. - 2. The Gift Card should be non-transferable and suitably pin protected.
- 3. Initially Service provider will have to provide Gift Cards free of cost to all e mployees. In case of issue of duplicate Gift Card, the charges will be paid by as per mutually agreed terms.
- 4. RCF shall provide detail list of employees which shall consist of Name and required detail of employee and amount to be credited.
- 5. Service provider shall credit amount specified by RCF Ltd. HR Dept. to employee on their card.
- 6. RCF employees shall use these Gift cards at various affiliates/merchants/o utlets/vendor. Payment to affiliates/merchants/outlets/vendor shall be mad e by service provider as per their mutual agreement. Service provider may deduct service charge from affiliates/merchants/outlets/vendor as per their mutual agreement.
- 7. RCF shall make the payment of amount credited by service provider as per agreed payment terms.
- 8. The list of affiliates/merchants/outlets/vendor of various localities shall be provided by the Service provider. In addition, the Service provider has to a dd the list given by RCF Ltd. of affiliates/merchants/outlets/vendor. Service provider has to ensure that affiliates/merchants/outlets/vendor shall accept the cards. Management may update the list of affiliates/merchants/outlets/vendor from time to time.
- 9. The notification of all the transactions on the Gift Card to be furnished thr

- ough electronic means through Email/Mobile SMS to our employees.
- 10. All necessary support and help will be provided by Vendor in connection with marketing employees which are located out of Mumbai and Maharasht ra.
- 11. RCF Ltd. desires pre-paid Gift Cards in electronic pre-paid form and does not desire employees to be spending cash/money and claiming reimbursem ent in any form. The Gift Card should be directly accepted at the bonafide Gift Card outlets without the need for the employee to handle any cash with regard to these transactions.
- 12. Acceptance of the Gift Card provided will be at the risk and cost of the ser vice provider including any related legal consequences.
- 13. The successful Bidder, who will be awarded the contract, should ensure s mooth functioning of the scheme in respect of delivery of Gift Cards.
- 14. The bidder has to ensure tie up with merchants or payment aggregators/ gateways for acceptance of Gift Card with contractual/legal responsibility on merchant/service provider for acceptance of Gift Card.
- 15. Bidder shall comply with regards to the Master Direction on Issuance and Operation of Prepaid Payment Instruments by RBI issued from time to time. These instruments do not permit cash withdrawal.
